The tool is a modular instrument that contains a basic core assessment and the following four supplements: functional, assisted living, mental health, and deafblind. The tool assess client needs in the following domains: Cognition, Communication and vision, Mood, Psychosocial Well-Being, Functional Status, Continence, Disease Diagnosis, Health Conditions, Oral and Nutritional Status, Medications, Treatment and Procedures, Social Relationships, Environment. These tools reduce duplication of assessments within the circle of care by sharing information and further facilitate inter-agency communication through a common language based on recognized data standards.
